Dear Resident of City of Saskatoon,



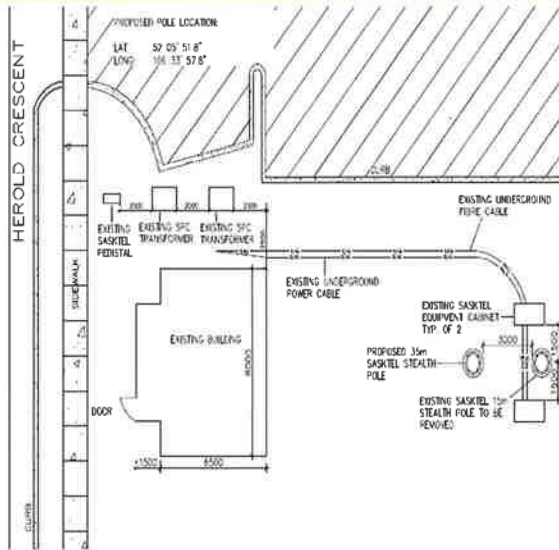
As more Canadians rely on wireless phone services for personal security, convenience, and business. SaskTel is required to respond to the demands of our customers by completing network expansion and improvements.

In order to allow for improved and additional wireless services in your community, we have applied to build a new replacement communication facility to support the requirements of wireless services. SaskTel proposes to design and construct a new wireless facility in the City of Saskatoon in order to provide enhanced wireless communications in the Lakewood, Lakeridge and Rosewood areas of the City of Saskatoon.

The purpose of this public notification package is to provide you with information on the details of our proposed facility, and how we selected the location in your community. You will find in this information package the location, and design of the proposed facility.

Proposed Telecommunications System



Proposed New Tower

The existing 14.9m stealth pole was installed in 2012. As the City continues to grow in this area better enhanced wireless capacity and coverage is required in order to meet the demands for wireless services. For meeting the wireless demands and coverage needed we have identified, it was determined that other infrastructure was either not available or could not be used.

Other Infrastructure

The location and the height of this new stealth pole maximizes the network coverage area, which cannot be achieved by the existing 14.9m facility.

Future Tower Sharing Opportunities

SaskTel towers are built to support multiple carriers and we welcome future tower sharing opportunities for this proposed tower.

Description of Proposed Antenna System



The proposed facility will consist of a 35m Stealth pole similar to the existing 14.9m stealth pole. The existing equipment cabinets will be reused . The existing 14.9m Stealth pole and foundations will be removed.
